

Terms and Conditions Jordan Petrol Stations Bonus Membership Rewards Points Campaign

Offer Period

Offer

Spend on your Card during the offer period and receive 100 bonus Membership Rewards points for every transaction made at petrol stations across Jordan, based on meeting the eligibility criteria set out below.

Purchases and Spend Thresholds

Eligible purchases mean purchases made at Service Establishments Points of Sale by Eligible Cards.

Purchases are restricted to those made for petrol only; any other products or services purchased at these establishments will not be eligible for the bonus points.

Each transaction made at a participating Petrol Station in Jordan will receive 100 bonus Membership Rewards points. Transactions made at Petrol Stations not participating in this offer will not be eligible to receive the bonus points. There is no minimum or maximum size for a transaction to be eligible to receive the bonus points.

The additional 100 bonus Membership Rewards points will be capped at 10,000 Membership Rewards points; this translates to making a total of 100 transactions during the offer period.
